

# **Guidelines to Developing your SEC Community Charter**

### What is a Community Charter?

A Community Charter is a **one-page overview of your Sustainable Energy Community's vision and goals**. It briefly outlines your commitments and **is signed on behalf of your SEC by nominated Steering Committee members**. Your signed Community Charter should be submitted as part of your Stage One Application to the SEC Partnership Agreement Programme. Once SEAI have received and approved your application, they will counter-sign your Community Charter signifying their commitment to work with you over the duration of your three-year partnership. The Community Charter is not a legal document; it is a statement of intent and represents the collective ambition of your community.

### How do we create one?

Below we have outlined the typical components included in effective Community Charters. Overleaf, are two sample Charters – one for a fictitious group and another developed by the Dundalk 2020 Árd Easmuinn project. This information is intended to serve as a loose guideline rather than a blueprint. You should create your own Community Charter that suits your needs and goals. To help you, we have created a graphically designed template available <a href="here">here</a>. This can be personalised for your SEC by inserting your own content.

# **Typical Community Charter Components**

#### Vision Statement

A one-sentence, aspirational statement describing what your SEC would like to achieve.

**Tip:** This could be collectively created by your Steering Committee using a visioning exercise. For this, everyone draws what their ideal 'picture' is for the SEC if everything went well and you had all the resources you needed (no artistic skills required!). People then discuss their images, identifying keywords to describe their core qualities. The group then discusses the similarities or differences that arose in this exercise and attempts to agree on a collective vision for the project. Post-its / flip charts are useful here.

# Elaborated Vision / Goals

An explanation on the initiatives and high-level goals your SEC plans to pursue to achieve your Vision. You may like to include this to broaden your vision statement beyond one sentence.

### **Guiding Principles**

A statement on how your group will operate to achieve its goals – this could relate to internal practices, how you will relate to other groups or partners, collaborate and create impact.

### Community Support

A sentence to note the level of support within the community for the project and / or commenting on progress to date.

### Commitments

A list of your SEC's key commitments. Commitments might relate to the following topics:

- Partnerships and engagement commitment to collaborate and engage effectively: within your group; with the SEC Network and SEAI; with members of the public and other stakeholders and authorities locally, regionally and nationally.
- Achievement of targets commitment to achieve specific targets for improving energy efficiency, increasing the share of renewables or reducing carbon emissions in your SEC (\*Note that not all groups include specific numeric targets).
- Integrated planning and reporting commitment to recording and reporting on progress regularly and to adopting an integrated, long-term planning approach.
- Achievement of vision and goals commitment to achieve your Vision may be reiterated in this section.
- Creating impact commitment to promote the project and the theme of sustainable energy across the community and Ireland.

**Tip:** For ideas on the kinds of Commitments you might like to include, you could refer to SEAI's Competency Evaluation Tool (here) that outlines the building blocks for a successful SEC.

# Dundalk 2020 Árd Easmuinn

#### Our Vision...

Is to stimulate a national move towards sustainable energy practice through demonstration in an exemplar community.

Vision Statement

The Dundalk 2020 project seeks to demonstrate how a community can move to a more sustainable pattern of energy supply and use. This project is to be an exemplar, first within the town of Dundalk, then the surrounding region and ultimately to Ireland as a whole. The project will achieve a substantial increase in the use of renewable energy, a significant improvement in the energy performance of the built environment, the provision of intelligent management of the supply / demand balance, and greater energy autonomy for the community.

Elaborated Vision/ Goals

In particular, Árd Easmuinn, through the use of a Structured Energy Management Programme, will achieve significant reductions in energy consumption through a campaign across 2008. SEAI and energy suppliers will actively work the Árd Easmuinn residents to help meet the challenge.
